Course Overview

This class is an introduction to American constitutional law, focusing on civil rights and civil liberties. The course addresses the litigation and enforcement of rights claims, including contests over rights to religious exercise, speech, property, guns, due process, fair labor conditions, affirmative action, equal protection, and racial, gender, and sexuality protections. The class has a historical orientation, showing how clashes between the political branches and parties have expanded and contracted rights claims over time. The class thus emphasizes how law and rights are politically constructed and contested, and prepares students to reason critically about these cases and about the law generally.

Course Requirements and Grading

Your course grade has four parts:

Participation 15%

Participation is based primarily on attendance. One absence is automatically excused. Subsequent absences are excused given documentation. Please read and bring the assigned material for each class. The participation grade for a given day may be based on a pop quiz on that day's readings.

Presentation 20%

The presentation should 1) give an original summary the facts, question, and judgment of a case, including quotes or references to justices' opinions in the case, 2) prompt discussion with at least one question (either during or after the presentation), and 3) last 8-10 minutes total. Students may use aids like a handout, but are not required to do so. If a student misses his or her assigned presentation date, he or she may reschedule, but will lose a third of a letter grade for each time rescheduled. Midterm Paper 25%

The midterm is a 5-7 page paper, due by email by **5:00 PM Friday, March 1**. The instructor will distribute paper topics and instructions by Feb. 18. Papers should include citations and/or a bibliography. Students may choose the citation style. Please use 10 to 12 pt. font and one inch margins.

Final Exam 40%

The final is an in-class exam on **May 7, 8:00-10:00 AM**, Howard Plaza Towers West P-52. Students unable to take the exam at the allotted time and graduating seniors must email the instructor at least three weeks before the exam date.

Students are expected to read and follow Howard University's [Academic Code of Student Conduct](#), including rules on cheating, plagiarism, etc. Plagiarized assignments, including papers, tests, quizzes, and presentations, will receive a zero.

Late assignments decrease a third of a letter grade per day for up to seven days.

Readings

The only required text for the course is: Gilman, Howard, Mark A. Graber, and Keith E. Whittington. 2016. *American Constitutionalism*. 2nd ed. Vol. II. Oxford: Oxford University Press.

The textbook (referred to as GGW) is available through the university bookstore and online. The first edition of the textbook is also available online at a lower cost than the assigned second edition, though the first edition has different content and page numbers.

The instructor will also post to Blackboard a packet of supplementary readings, drawn mainly from Vol. 1 of GGW and also from O'Brien, David M. 2017. *Constitutional Law and Politics*. Vol. 1 and 2. W.W. Norton. Since the packet will include all additional readings, these books are not required for purchase.
